Dear Member Applicant;

Thank you for your interest in joining the Springvale Pistol Club. The pistol club was formed on the 17th June 2004 and is affiliated to Victorian Amateur Pistol Association Inc. The clubs intension is promote the sport of pistol shooting to enable its members to visit and compete in competitions at other pistol clubs in Victoria or interstate in your chosen pistol disciplines.

This pistol club is a sub-club of the Sporting Shooters Association Of Australia (Vic) and consequently to join this pistol club you **MUST** be a financial member of the S.S.A.A. If you are not a member you are required to join; this can be done by completing an application form (available from the Range office). You must complete two copies of FORM 1 and a Form A application. You must also include two passport photos. The FORM 1's will be completed by a member of the Committee of Management when your application is submitted for approval by the said Committee of Management.

Other Costs

1. SSAA membership fee **\$70.00** per adult member, a lesser fee applies for family and junior memberships.
2. National Name Check **\$24.70**. All applicants are required to obtain a National Name Check and provide the results with the membership application. Forms for the Consent To Check & Release National Police Record are available from a police station.
3. Handgun Safety Course **\$45.00** for members, and **\$105.00** for non-members it is a requirement that new members attend this course which is conducted on the **3rd** Saturday of the month. Please register your intention to attend at the Range office.
4. New members are required to apply for a Provisional Handgun Licence which applies for a minimum of 6 months. The cost for this permit is **\$85** and it is valid for 6 months; a pass in the Safety Course (Item 3. Above) must be achieved by the **3rd** month of the Provisional Licence. After 6 months, the Committee of Management may endorse your application for a Handgun License.

Application for membership must be made in person, all applications are considered on the 3rd Wednesday of the month, applicants are required to attend at 8.00 pm to meet the committee. You are required to bring with you the results from the National Name Check as mentioned above. You also need to bring with you two personal references from people you have known for more that two years (not family members). This is a requirement of the Victorian Police and is mandatory your membership.
